1. Pursuant to the provisions of Clause I.144, the first sentence of paragraph (a) is hereby changed to read as follows: "The amount presently obligated by the Government with respect to this contract is \$5,167,315,814.64."

This represents an increase of \$119,659.21 from \$5,167,196,155.43 to \$5,167,315,814.64 (\$3,416,296,389.13 obligated by Oak Ridge Office and \$1,751,019,425.51 obligated by the NNSA Service Center). \$3,100,000 of the total obligated amount is for transition activities. This change is the result of a net increase by the NNSA Service Center on FY 2007 Approved Funding Programs No. 16, 17 and 18.

2. Reference Modification A156.

Delete the following sentence:
